

**CERTIFICATION OF ELIGIBILITY
RELEASE AND WAIVER OF LIABILITY**

- A. To establish my eligibility under section 5503 title 36 USC to participate in any activity sponsored or supported by the Civilian Marksmanship Program (CMP), I hereby certify that:
1. I have not been convicted of any Federal or State felony or violation of section 922 title 18 USC and,
 2. I am not a member of any organization that advocates the violent overthrow of the United States Government.
- B. In consideration for being permitted to participate in any shooting event sponsored or supported by the CMP or the Oak Ridge Sportsmens Association Inc. (ORSA) I hereby declare that I fully understand, and agree to the following:
1. Participating in shooting events exposes participants to various safety hazards;
 2. No one but myself (or guardian if under 18 years of age) is responsible for my safety when I choose to participate actively in shooting events.

I represent that I am in good physical condition, and I certify that I have no physical defects or injuries which would prevent me from participating in shooting events. I fully understand and agree that, while participating in shooting events there is the possibility of unknown, uncontrollable dangers and accidental or other physical injury, and I willingly assume that risk.

NOW THEREFORE, IN CONSIDERATION FOR PERMITTING ME TO PARTICIPATE IN ANY SHOOTING EVENT SPONSORED OR SUPPORTED BY CMP OR ORSA, AND INTENDING TO BE LEGALLY BOUND, I HEREBY RELEASE, WAIVE, DISCHARGE and COVENANT for myself, my estate, heirs, executor, administrators and for anyone else claiming through me, my right to sue the OAK RIDGE SPORTSMENS ASSOCIATION or the CORPORATION FOR THE PROMOTION OF RIFLE PRACTICE AND FIREARMS SAFETY, their officers, representatives, agents, employees, range officials, and official referees and release these organizations and individuals from all liability for any and all loss or damage and any claim or demands thereof on account of injury to my person or property which may occur in connection with shooting events sponsored or supported by the Oak Ridge Sportsmens Association or the Civilian Marksmanship Program. This waiver applies to any negligent act or omission, and to any intentional act intended to promote my safety or well being. I hereby agree to indemnify and save and hold harmless the Oak Ridge Sportsmens Association and the Corporation for the Promotion of Rifle Practice and Firearms Safety from any loss, liability, damage or cost they may incur arising from any negligent or wrongful conduct by me.

I hereby agree to assume full responsibility for the risk of bodily injury, death, or property damage due to the negligence of the Oak Ridge Sportsmens Association or otherwise.

This waiver is given in the interest of permitting the Oak Ridge Sportsmens Association to exist and to serve the shooting community, and to enable myself and my fellow shooting competitors to feel free to donate their services to improving the sport and training those less skilled than ourselves without fear of liability.

MY WAIVER IS GIVEN IN EXCHANGE FOR SIMILAR WAIVERS TO BE GRANTED ON MY BEHALF BY OTHER PARTICIPANTS IN ORSA SHOOTING EVENTS.
